b. Overview of District Finances

Staff distributed and briefly explained a handout summarizing the sources of District revenues for each year since the beginning of the District in 2007.

- c. Panel Discussion of other regional park and open space district funding strategies and experiences with:
 - --Bob Doyle, General Manager of East Bay Regional Park District
 - --Linda Dahl, General Manager of Marin County Open Space District
 - --Steve Abbors, General Manager of Midpeninsula Regional Open Space District

Each speaker briefly described the history of their district, how they are funded, and recent experiences seeking voter approval of new funding. Key points made by the speakers included:

- Voter opinion research is critical to make sure that what you do reflects public values.
- Voters have historically strongly supported purposes such as protection of wildlife habitat, natural open spaces and water quality, and providing outdoor recreation.
 Voters have also been increasingly supportive of funding for improved maintenance of public spaces and environmental education.
- Partnering with others is essential (for EBRPD, this has meant including block grant funding for city park and recreation programs; for Marin County Open Space

District and Midpeninsula Regional Open Space District, this has meant earmarking funding for conservation projects sponsored by local non-profit organizations.

- It is critically important to meet with your critics as well as your supporters, and really listen to what they say.
- Voters want to see a citizen's oversight committee before they will support new funding.
- Voters want to see a sunset provision on any new tax.
- Any new tax specific to park, recreation and open space purposes requires a 66.67 % supermajority "yes" vote.
- Other Districts have obtained voter support to issue bonds for capital projects and acquisitions (repaid through the *ad valorem* property tax), increase parcel taxes for capital and/or operating purposes, and increase sales taxes for capital and/or operating purposes.
