# **STAFF REPORT**

Date:October 8, 2012Agenda Item:4.C.Subject:Consideration and potential approval of amendments to the budget for FY 2012-13

Recommendation

Approve the amended budget as presented in Attachment 1

# Background

Now that the first quarter of the fiscal year is under our belt, it is time to make several adjustments to the budget to reflect new information. The proposed amendments are attached; those cells in the spreadsheet which are proposed to change are highlighted in yellow.

Reasons for these amendments are as follows:

- When the budget was adopted, it was not known how much of a carryover of funds there would be from the prior fiscal year. That figure is now expected to be \$258,848, pending confirmation by the District's independent financial audit. The majority of these funds are recommended to be applied to Moore Creek. With this adjustment, there should be ample funding to complete several major projects and open the park to the public this fiscal year. These improvements include finishing the staging area, constructing the staging area composting toilet facility, constructing a new engineered septic system for the ranch house, and finishing the boundary survey and fencing work. The rest of the carryover funds have been applied to the General Fund Contingency/Special Projects line item.
- During last fiscal year the County transferred to the District the remainder of the funds the County had committed to Moore Creek. Due to uncertainties about whether various expenses would be booked in the last fiscal year or the current fiscal year, the adopted budget assumed \$150,000 of these funds would be available for this fiscal year. The actual amount (subject to audit confirmation) is \$166,133.
- The budget assumed the worst-case that \$90,000 would be needed for election costs. Since there ended up being no contested races, these funds have been shifted to the Contingencies/Special Projects line item.
- The budget as adopted distributed the General Manager's time to each project area, in an attempt to get a more accurate picture of how resources are spent for each project. This has proven to be impractical, because the GM's time is spread out thinly and changes depending on how projects evolve and what kinds of challenges arise. The recommended budget puts the GM's time into the General Fund, with the exception of those projects with dedicated grant funding where it is necessary to capture the GM's time in order to either invoice for that time or track the local match for those grant funded projects.

• The recommended budget assumes that the project manager contracted from the county will increase from the initially-budgeted 50% FTE to approximately 80% FTE for the year. Because the person who fulfills this function has some remaining county projects to complete, there will need to be a phase-in period for this increase in staffing; he goal is to have this be a full-time position before the end of this fiscal year.

In considering these amendments, the Board should keep in mind that the Board's budget control is expenditures for the project bottom line, not each line item within each project; the line by line detail within each project is provided so that the Board has a sense of how the funds within each project are proposed to be used

# **Recommendation**

Receive the report, and give direction to staff on the desired content and format of future reports.

# Background

Section III.A.(7) of the District By-laws authorizes the General Manager to bind the district for supplies, materials, labor, and other valuable consideration, in accordance with board policy and the adopted District budget, up to \$10,000 for non-construction purposes and up to \$25,000 for construction purposes, provided that all such expenditures are subsequently reported to the Board of Directors. Section III.A.(8) of the By-laws authorizes the General Manager to apply for grants and receive donations, subject to reporting such actions to the Board of Directors.

Because District finances have become more complex, for the September report, staff experimented with providing the complete printout showing all expenditures, not just those required to be reported to the Board, both to save report preparation time as well as reduce the potential for mistakenly failing to report any expenses which require reporting to the Board. The Board expressed support for this revised reporting approach.

Attached is the printout of expenses for September 2012.

Continuing damage by off-road vehicles trespassing on the property was noted. The District sent a letter was sent to all property owners in that area introducing the District, explaining the deed restriction prohibiting off road vehicles, and asking for their cooperation. Since then there has been less observed damage, although the problem is not resolved. No further work is anticipated until Lake Berryessa Trail planning is completed, as that is a key step in gaining overland access to the property. District staff has been meeting with Reclamation, their consultants and interested parties on the trail planning and prioritization.

Redevelopment of former Boy Scout Camp into a group/environmental education camp.

CEQA and NEPA review is complete, as is the Use Agreement between the District and Reclamation. A grant for \$50,000 to help with construction has been provided by the Mead Foundation, together with a \$1.5 million grant from the State Coastal Conservancy. The contract for preparation of plans and specifications with Psomas was approved by the Board at its October meeting, and Psomas has now completed the 60% drawings, which are being reviewed by District and Reclamation staff. A meeting of potential future users was held September 22, 2011. The District has contracted for labor compliance monitoring for the construction work. Efforts to reuse the existing well proved unsuccessful, though water quality tests did demonstrate the groundwater in the area is of acceptable quality. Reclamation has approved drilling a new well to replace the existing non-functioning well, <u>a well drillier has been contracted</u>, and well drilling work should begin the week of October 8th. The camp will likely open in the fall of 2013.

#### District Non-profit Foundation

Organize a non-profit foundation to raise funds for District projects The District Board has approved the goals, objectives and basic structure for a non-profit foundation to assist the District with fundraising. Formation of the foundation will likely be timed to the opening of Camp Berryessa.

Lake Hennessey North Shore Trails

#### Moore Creek Open Space Park Development

Development of open space park on 673 acres acquired by the District adacent to City of Napa watershed lands at Lake Hennessey to protect habitat, provide recreational trails, and overnight camping facilities.

Napa River Ecological Reserve Restoration

Remove invasive plants and restore native vegetaion in the entryway meadow, replace damaged signage and information panels, and if feasible install a seasonal bridge All discretionary permits have been obtained, and park improvements are underway. The County road department completed paving of the entryway driveway in November 2012. The design of the new septic system for the ranch house has been approved by the Regional Water Quality Control Board and the County. The eastern boundary survey is complete except for a small amount of flagging; a partial payment to the surveyor has been worked out, since he cannot finish flagging until brush clearance work is completed. Monthly volunteer work parties have performed numerous tasks on the property, including trail repair and construction, fence building, restoration planting, and removal of invasive french broom. In 2012, the ranch house was used by VOCAL for a crew leader training in March, and a Land Trust first aide training in February. Construction of the South Segment of the Valentine Trail has been completed, with only minor hand clean-up required at this point. Staging area fill and compaction is under way and will likely be completed by the time the Board reads this. Delays in the processing of building permits for the trailhead restrooms and a lack of staff time to quickly put together a bid package for the alternative septic treatment system have pushed the expected public opening back to Soring 2013.

The CCC did mechanical and chemical weed removal and installed an all-weather surface on the trail from the parking area to the river levee, in May and June 2010. Additional invasive weed removal, mapping, and cleanup was done by volunteers on numerous occassions in 2010, 2011 and 2012. The District has used grant funding to bring several thousand students to the site to study ecology of the area and assist with the habitat restoration. Staff met with invasive plant control specialists in June 2011 to evaluate eradification efforts to date and plan next steps. Native plant cuttings gathered from the reserve were propagated and planted by volunteers in Dec 2011 and Jan 2012. Supplemental grant funding for the restoration work was awarded by the County Wildlife Commission in 2011. Both the Coastal Conservancy grant and the Wildlife Commission grant the District received to pay for restoration work have had their deadlines extended until March and June of 2013. This time extension will allow us to continue invasive weed removal. DFG in 2011 agreed to a simplified approval process for field trips. District staff met with DFG on December 8, 2011 to agree on work plans for 2012. Several school field trips have been held since the beginning of the calendar year, and a private contractor was hired in spring 2012 to perform additional invasive plant removal.
