Subject: Consideration and release of draft budget for FY 2019-20

RECOMMENDATION

Amend the draft budget for FY 2019-20 as desired, then release the draft for public comment and set a public hearing and potential adoption for June 9, 2019.

ENVIRONMENTAL DETERMINATION

The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND

A draft budget for fiscal year 2019-20 (July 1, 2019 through June 30, 2020) is attached. Notable features of the draft budget include:

- The County grant, based on a percentage of the Transient Occupancy Tax revenues collected by Napa County, will be declining next fiscal year by \$118,000, to a total of \$916,001. This is primarily due to the effects of the October 2017 wildfires; each year's grant is based on the amount collected in the prior full fiscal year.
- In the coming fiscal year, \$150,000 is allocated to pay for election costs. This is not a precise figure because the exact costs vary based on the number of items on the ballot from different agencies. Our estimate assumes that a District funding measure will be on the March 2020 primary election ballot. *Note*: if there are any contested Board of Director's seats, those elections would be held in November 2020 and as a result the costs would not hit until the FY 2020-21 budget.
- Included in the budget is funding for the acquisition of the 164 acre Chamberlain property. The budget assumes \$600,000 is obtained from State grants (\$400,000 from the Prop 68 Per Capita grant program, and \$200,000 from the Habitat

Conservation Fund), with the District drawing on approximately \$300,000 of its reserves for the remainder.

- The budget provides sufficient funding to continue the restoration of the Cove and to reopen the campground before the end of the fiscal year.
- The costs for a new half-time planner position and a new half-time staff services analyst are included in the budget. These new positions are needed to increase staff capacity. In the current fiscal year, expenses are projected to end up substantially lower than budgeted, in large part because the District planning staff is maxed out and does not have the capacity to manage and advance all of the projects for which the District has obtained funding. These new positions may ultimately be hired as either District or County employees, depending on who is selected. When adopting the final budget in June, the Board will also need to allocate positions and approve salary ranges for all permanent District employees.
- "District Salaries and Benefits" includes personnel expenses for District employees. "Administrative Services" includes personnel expenses for County employees contracted to the District. Total personnel expenses are projected to increase by just over \$200,000 next fiscal year. Most of this increase will be offset by a projected decrease in Other Professional Services. This shift is due to the fact that over the past several months the District has replaced several private professional services contracts with two new employees and expanded hours for several part-time employees.
- The budget assumes the last trail currently slated for construction in the Lake
 Hennessey Unit of Moore Creek Park will be completed this fall, with the work being
 done primarily by Conservation Corps North Bay using grant funding they have
 applied for (though not yet guaranteed) under the close supervision of District staff.
- State Park revenues are projected to remain the same as the current fiscal year. Expenses are projected to increase, primarily to undertake the next round of deferred maintenance and improvement projects. New capital projects were mostly not undertaken in the current fiscal year, in part because the District has been waiting for the new long term operating agreement to be signed before embarking on major new projects, and in part because State Parks-sponsored ADA improvements diverted considerable District staff resources to deal with the disruption caused by the construction. Overall, in the current fiscal year State Park revenues exceeded revenues, and the available fund balance as of June 30, 2019 is projected to increase by about \$50,000 compared to one year prior. The draft budget assumes increased District-paid construction activity, with a resulting small decrease in the available fund balance projected as of June 30, 2020.
- The budget assumes the District constructs the red-legged frog pond that was required as part of the grant funding the District obtained to acquire Suscol Headwaters Preserve. Whether the pond actually gets built in the coming fiscal year will depend on how quickly Caltrans and U.S. Fish and Wildlife Service come to agree on the design of the pond.

- The budget assumes a continuation and further expansion of the District's naturalist and community engagements programs, including guided youth and adult hikes and nature exploration, overnight camp at EcoCamp Berryessa, summer day camp at Bothe-Napa Valley State Park, the Spring Trails Challenge, and monthly District newsletter.
- Overall, the proposed budget consists of approximately \$800,000 in on-going operating costs, with the remainder of the proposed \$2.16 million budget allocated to one-time land acquisition and capital improvement projects.

2050.

RECOMMENDATION

1. Find that the proposed action is not a project under CEQA

2. Direct the General Manager, or his designate, to sign on to the letter of support for SB 474 (Stern) circulated by Defenders of Wildlife.

ENVIRONMENTAL DETERMINATION

The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND

The District's success in its first decade of work has, financially at least, relied on a combination of the annual TOT grant from the County of Napa and outside grants leveraged at a ratio roughly three to one. A major source of outside grants has been from State agencies using funds provided by a combination of statewide resource bond measures. While bond monies have been responsible for many of the District's largest and most important capital projects, the one-time nature of the mechanism creates something of a feast or famine funding regime. In a world of climate change and relentless pressure from urban and other development, the argument has been made that habitat protection investments require a more predictable funding source.

In an attempt to remedy this situation, in 1990 (now nearly thirty years ago!) California voters enacted Proposition 117, which created the Habitat Conservation Fund and obligated the State

to transfer \$30 million per year into the fund until the year 2020. Proposition 117 specified that half the \$30 million each year be spent in northern California and half in southern California. Each year, no less than three million dollars must be spent statewide on acquiring and restoring stream and riparian habitat and three million dollars on acquiring and restoring wetlands. One-third of the money (\$10 million) must be spent to protect deer and mountain lion populations, with special emphasis on native oak forests. The remaining \$20 million a year must be spent on other types of wildlife habitat for threatened and endangered species or unique habitat types, with special preference given to land protection projects that create wildlife movement corridors.

HCF Funding is also authorized to provide public access, outdoor educational programs, and the building and restoration of trails. Funds are split on a fixed basis between local park districts, State Parks, the Conservancies, and the Wildlife Conservation Board (which distributes the lion's share). The District has benefited from a number of grants from the Habitat Conservation Fund over the years, including for the acquisition of Smittle Creek and the now-aborted Montesol acquisition. We currently have an HCF grant application in to fund the Chamberlain II purchase on Mount Veeder.

Senator Henry Stern (D- Canoga Park) has introduced a bill to extend the sunset of the Habitat Conservation Fund to 2050 without making any other substantive changes to the terms of Proposition 117 itself. A draft of the proposed legislation is attached for your review. SB 474 has passed out of the Senate Natural Resources and Appropriations committees with no opposition and is being supported by nearly all of our friends in the conservation and open space communities. The District has been asked by Defenders of Wildlife, who are organizing on behalf of the measure, to sign on to a letter of support for SB 474. We recommend that the Board direct the General Manager, or his designee if the GM is abroad or otherwise indisposed, to sign on to the letter of support on the District's behalf.

No. 474

Introduced by Senator Stern

February 21, 2019

An act to amend Section 10500 of the Water Code, relating to water. Sections 2787, 2791, and 2796 of the Fish and Game Code, relating to wildlife, and making an appropriation therefor.

LEGISLATIVE COUNSEL'S DIGEST

SB 474, as amended, Stern. Department of Water Resources: appropriations of water. *The California Wildlife Protection Act of 1990: Habitat Conservation Fund.*

Proposition 117, an initiative measure approved by the electors at the June 5, 1990, direct primary election, certain provisions of which can be amended by a majority vote, enacted the California Wildlife Protection Act of 1990. The act creates the Habitat Conservation Fund and requires the moneys in the fund to be used for specified purposes generally relating to the acquisition, enhancement, or restoration of wildlife habitat. The act requires the Controller, until June 30, 2020, to annually transfer \$30,000,000 from the General Fund to the Habitat Conservation Fund, less any amount transferred to the Habitat Conservation Fund from specified accounts and funds. The act, until July 1, 2020, continuously appropriates specified amounts from the Habitat Conservation Fund to the Department of Parks and Recreation, the State Coastal Conservancy, the Santa Monica Mountains Conservancy, and the California Tahoe Conservancy, and continuously appropriates the balance of the fund to the Wildlife Conservation Board.

This bill would require the Controller to continue to annually transfer \$30,000,000 from the General Fund, less any amount transferred to

the Habitat Conservation Fund from specified accounts and funds, to the Habitat Conservation Fund until June 30, 2050, and would continuously appropriate that amount on an annual basis in the same proportions to the specified entities until July 1, 2050.

Under existing law, the Department of Water Resources is required to make and file with the State Water Resources Control Board applications for the appropriation of any water that, in the department's judgment, is or may be required in the development and completion of all or part of a general or coordinated plan for the development, utilization, or conservation of the water resources of the state. Existing law gives those applications priority, as of the date of filing the application, over any subsequent application and exempts certain water rights diligence provisions from generally applying to the applications.

This bill would eliminate the exemption from the application of the diligence provisions as of January 1, 2021.

Vote: majority-2/3. Appropriation: no-yes. Fiscal committee: yes. State-mandated local program: no.

The people of the State of California do enact as follows:

- 6 (a) To the Department of Parks and Recreation, four million five hundred thousand dollars (\$4,500,000) annually for allocation as follows:
- 9 (1) One million five hundred thousand dollars (\$1,500,000) for 10 projects that are located in the Santa Lucia Mountain Range in 11 Monterey County for expenditure by the Department of Parks and 12 Recreation and for grants to the Monterey Peninsula Regional Park 13 District.
 - (2) One million dollars (\$1,000,000) for acquisitions in, and adjacent to, units of the state park system.

areas. The grants made pursuant to this subdivision are subject to the conditions of subdivision (d) of Section 5910, and Sections 5917 and 5919, of the Public Resources Code, as nearly as may be practicable.

- (b) To the State Coastal Conservancy, four million dollars (\$4,000,000) annually.
- 7 (c) To the Santa Monica Mountains Conservancy, five million 8 dollars (\$5,000,000) annually for the next 10 fiscal years, commencing with the 1990-91 fiscal year. The money shall be 10 used for the purposes specified in Section 2786 for wildlife habitat, 11 and for related open-space projects, within the Santa Monica 12 Mountains Zone, the Rim of the Valley Corridor, and the Santa 13 Clarita Woodlands. - (c) Notwithstanding the requirement for acquisition in subdivisions (a), (b), and (c) of Section 2786, the board shall, to the extent practicable, expend the money in the fund in a manner and for projects so that, within each 24-month period, approximately six million dollars (\$6,000,000) of the money, including, until July 1, 2020, 2050, the expenditures by the agencies receiving money from the fund pursuant to subdivisions (a) to (d), inclusive, of Section 2787, are expended for the purposes specified in subdivision (d) of Section 2786.
- (d) Notwithstanding the requirement for acquisition in subdivisions (a), (b), and (c) of Section 2786, the board shall, to the extent practicable, expend the money in the fund in a manner and for projects so that, within each 24-month period, approximately six million dollars (\$6,000,000) of the money, including, until July 1, 2020, 2050, the expenditures by the agencies receiving money from the fund pursuant to subdivisions (a) to (d), inclusive, of Section 2787, are expended for the purposes specified in subdivision (e) and (f) of Section 2786.
- (e) To the extent practicable, the board shall expend the money appropriated to it from the fund in a manner and for projects so that, within each 24-month period, approximately one-half of the total expenditures of the money in the fund, including, until July 1, 2020, 2050, the expenditures by the agencies receiving money from the fund pursuant to subdivisions (a) to (d), inclusive, of Section 2787, are expended in northern California and approximately one-half in southern California.
- (f) Subject to the other requirements of this section, the board may allocate not more than two million dollars (\$2,000,000) annually for the purposes of this chapter to one or more State state agencies created by the Legislature or the people which that are

1 authorized by other provisions of law to expend funds for the 2 purposes of this chapter.

- SEC. 3. Section 2796 of the Fish and Game Code is amended to read:
- 2796. (a) The Controller shall annually transfer the sum of thirty million dollars (\$30,000,000) from the General Fund to the Habitat Conservation Fund, less any amount transferred to the Habitat Conservation Fund from, but not limited to, the following accounts and funds:
- (1) The Public Resources Account in the Cigarette and Tobacco Products Surtax Fund to the extent authorized by the Tobacco Tax and Health Protection Act of 1988.

 - (3) The California Environmental License Plate Fund.

- (5) Any other non-General Fund accounts and funds created by the Legislature or the people for purposes which that are consistent with the purposes of this act.
- (6) Any bond funds—which that are authorized by the people after July 1, 1990, which that may be used for purposes which that are identical to the purposes specified in Section 2786.
 - (7) The Wildlife Restoration Fund.

- (b) Except for transfers from the Endangered and Rare Fish, Wildlife, and Plant Species Conservation and Enhancement Account, transfers from the Fish and Game Preservation Fund are not transfers for purposes of subdivision (a) and shall not be made to the fund. Transfers of federal, local, or privately donated funds or transfers from the State Coastal Conservancy Fund pursuant to Section 31011 of the Public Resources Code to the fund are not transfers for purposes of subdivision (a).
- (c) This section does not limit the amount of funds—which that may be transferred to the fund or—which that may be expended for fish and wildlife habitat protection either from the fund or from any other sources.
- 38 (d) This section shall become operative on July 1, 1990, shall become inoperative on June 30, 2020, 2050, and, as of January 1, 40 2021, 2051, is repealed, unless a later enacted statute, which

becomes effective before January 1, 2021, 2051, deletes or extends
 the dates on which it becomes inoperative and is repealed.

SECTION 1. Section 10500 of the Water Code is amended to read:

- 10500. (a) The department shall make and file applications for any water that in its judgment is or may be required in the development and completion of the whole or any part of a general or coordinated plan looking toward the development, utilization, or conservation of the water resources of the state.
- (b) Any application filed pursuant to this part shall be made and filed pursuant to Part 2 (commencing with Section 1200) of Division 2 and the rules and regulations of the State Water Resources Control Board relating to the appropriation of water insofar as applicable.
- (c) Applications filed pursuant to this part shall have priority, as of the date of filing, over any application made and filed subsequent to that date.
- 18 (d) The statutory requirements of Part 2 (commencing at Section 1200) of Division 2 relating to diligence shall not apply to applications filed under this part, except as otherwise provided in Section 10504. This subdivision shall become inoperative January 1, 2021.

BACKGROUND

April 2019 Bothe-Napa Valley State Park/Bale Mill Report:

- Construction Update: The contractor is nearly done. Staff has fixed some things repaired some out of scope work.
- Naturalists led the fourth of the 2019 hike series on April 20th at the American Canyon Wetlands. The Bird hike had 17 attendees who were treated to a variety of shorebirds and other species! The weather was great attendees learned the basics on species identification.
- Both Mill and Park attendance and occupancy has jumped significantly in April due to Spring break vacations and beautiful weather.
- The FY 19-20 draft budget was developed and proposed for NCRPOSD board approval.
- The FY 19-20 project plan (wish list) was prepared and sent to NVSPA board consideration.

- Staff met with State Parks interim District Superintendent to go over SP project priorities and deferred maintenance list.
- Three Bale Mill Field trips were held in April, serving 175 students and 24 adults.
 New programs combining mill history and short naturalist hike have worked well.
- Five Bothe Filed Trips were held in April, serving 207 students and 45 adults.
- The Dia del Nino/Earth day event was held on April 27th. Activities included guided hikes, crafts, discovery table, food and partner booths. Attendance was lower than we hoped with approximately 30 children in attendance.
- Not State Park related, but staff is assisting trail building effort at Moore Creek Park.
- Park Aid and Miller recruitment ongoing with limited applicants. Attended Chamber mixer at Calistoga High for recruitment opportunities.
- Mowing, vegetation management ongoing due to high rain year. Thank you to NVSPA for new mower which has made a big difference.
- Two PEF's submitted to SP for approval. Drafting water wheel replacement PEF to be submitted soon.
